**Party Policies**

1. Our 2-hour party includes exclusive use of the studio and all of Beanie Yogini materials and equipment, plus an instructor and -assistant team who will lead the activities and take care of pre-party setup and post-party cleanup...

In the unlikely event that your party is unusually messy and takes more than 30 minutes for our staff to clean up, or that you or your guests do damage to our materials, equipment or property, you will be charged an additional fee based on the time, effort and expense required to restore our facility to its pre-party condition.

2. We provide all food (**except birthday cake**) All parties include Pizza service with our delicious Signature cupcakes. A Spa menu is available and is a balanced offering with seasonally fresh fruit and sweet vegetable, Tea Sandwiches, Cheese, crackers, yogurt, jello and a selection of snack items and Spring water. All paper goods are provided.

3. Although our basic party offers more than enough activities to keep your guests busy, if you wish, you are welcome to hire additional entertainment (e.g., face painting, magician, puppet or bubble show). We can provide you with a recommended list of talented and trustworthy party professionals at your request.

4. Unless prior arrangements are made, the first 1.25 hours of the two-hour party will consist of a combination of supervised play, mindfulness activity, yoga practice with our selection of props and materials, and music and art activities facilitated by our staff. The next thirty minutes of the party are set aside for serving of food and cake. The final 15 minutes will offer games or large motor activities per your request, as well as a time for saying goodbye and handing out party favors.

5. If there are any favorite songs or activities you want to be sure are a part of your child's party, please let us know.

6. Birthday parties require a 50% deposit to reserve the date and time, with no refunds given after one month prior to the scheduled party. The remaining 50% is due on the day of the party. Nonrefundable deposits can be applied to another party if it is held within one month of your originally-scheduled party date (availability permitting).
